COOPERATIVE ENDEAVOR AGREEMENT

This Cooperative Endeavor Agreement is entered into this 15th day of 2017 by and between:

Lafourche Parish Government, whose mailing address is Post Office Drawer 5548, Thibodaux, Louisiana 70302, hereinafter referred to as "PARISH" and represented by its Parish President, James B. Cantrelle, and

City of Thibodaux, whose mailing address is 310 West 2nd Street, Thibodaux, Louisiana 70302, hereinafter referred to as "CITY" and represented by its Mayor, Tommy Eschete.

1. PURPOSE

The PARISH is partnering with CITY to provide funding from the State of Louisiana's Parish Transportation Revenue Program Funding to offset the City's roads systems maintenance costs. Historically, 16.35% of the total amount paid to Lafourche Parish was designated within the appropriation bill as payable to the City of Thibodaux for roads systems maintenance costs pursuant to La R.S. 48:751-756. For the 2017-2018 fiscal year, this designation remains at 16.35%. Therefore, the PARISH is partnering with CITY to provide funding from the State of Louisiana's Parish Transportation Revenue Program Funding to offset CITY's roads systems maintenance costs.

2. GENERAL CONDITIONS

This agreement is pursuant to Lafourche Parish Council Resolution 17-____ of the June 13, 2017 council meeting.

3. TERMS

It is agreed between the parties:

- a. CITY shall:
 - i. Use the funds provided by Lafourche Parish Government to assist with the CITY'S roads systems maintenance costs.

b. PARISH shall:

i. Remit monthly payments to CITY in the amount of 16.35% of the amount paid directly to Lafourche Parish Government by the Louisiana Department of Treasury for the State of Louisiana's 2017-2018 fiscal year.
