NOTICE IS HEREBY GIVEN pursuant to Article 7, Section 23(C) of the Constitution and R.S. 47:1705(B) that a public hearing of the Thibodaux City Council will be held at the regular meeting place, City Council Chambers, City Hall, 310 West 2nd Street, Thibodaux, Louisiana, on Tuesday, July 18, 2017 at 5:00 PM to consider levying additional or increased millage rates without further voter approval or adopting the adjusted millage rates after reassessment and rolling forward to millage rates not to exceed the prior year's maximum. The estimated amount of tax revenue to be collected in the next tax year from the increased millage for General Alimony is \$535,764.17, and the amount of increase in taxes attributable to the millage increase is \$41,620.42; the increased millage for Special Improvements-Streets is \$292,429.05, and the amount of increase in taxes attributable to the millage increase is \$22,410.93; the increased millage for Special Improvements-Fire is \$195,308.45, and the increase in taxes attributable to the millage increase is \$14,939.16.
