

**OFFICIAL MINUTES OF THE CITY COUNCIL
CITY OF THIBODAUX

The City Council of the City of Thibodaux assembled in regular session at its regular meeting place, City Hall, 310 West 2nd Street, Thibodaux, Louisiana, on Tuesday, April 3, 2018 at 5:00 P.M.

There were present: Councilmen Richard, Badeaux, Mire and Councilwoman Johnson.

Councilman Tabor arrived at 5:01.

There were also present: Mayor Tommy Eschete and Beau Brooks.

Absent: None

The minutes of the March 20, 2018 City Council Meeting were approved as written.

Councilwoman Johnson introduced an ordinance to authorize the Mayor to execute a cooperative endeavor agreement with Nicholls State University (2018 Manning Camp). The Public Hearing on this ordinance will be held at the Council meeting on Monday, April 16, 2018 at 10:00 a.m.

The Planning and Zoning Commission recommends that the City Council consider an ordinance to approve the sketch, preliminary and final plat for the division of property located on the west side of St. Louis Street approximately 145' south from West 6th Street. The proposed division is of Lot 51 into Lots 51-A and 51-B.

On motion of Councilman Badeaux, seconded by Councilman Richard, the Council voted on an ordinance to approve the division of property on St. Louis Street belonging to Anthony Dover – Lot 51 into Lots 51-A and 51-B. Upon roll call the vote was as follows:

***AN ORDINANCE APPROVING THE DIVISION
OF PROPERTY ON ST. LOUIS STREET BELONGING TO
ANTHONY DOVER – LOT 51 INTO LOTS 51-A AND 51-B***

BE IT ORDAINED by the City Council of the City of Thibodaux in regular session assembled, that:

WHEREAS, the Planning and Zoning Commission of the City of Thibodaux has reviewed a request by Leonard Chauvin, P.E. on behalf of Anthony Dover for sketch, preliminary, and final plat approval of the division of property located on the west side of St. Louis Street approximately one hundred forty-five (145') feet south from West 6th Street; and

WHEREAS, the proposed request involves the division of Lot 51 into Lots 51-A and 51-B; and

WHEREAS, the said commission has approved the aforesaid request at their March 7, 2018 meeting, and is recommending that the City Council concur with their recommendation; and

WHEREAS, in accordance with the provisions of Section 18-53 of the Thibodaux Subdivision Regulations, this division should be accepted by the adoption of an appropriate ordinance.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Thibodaux in regular session assembled, that the division of property belonging to Anthony Dover as recommended by the Planning and Zoning Commission is hereby accepted and approved as requested.

BE IT FURTHER ORDAINED that a copy of the plat illustrating the said re-division is attached hereto and thereby made a part hereof.
