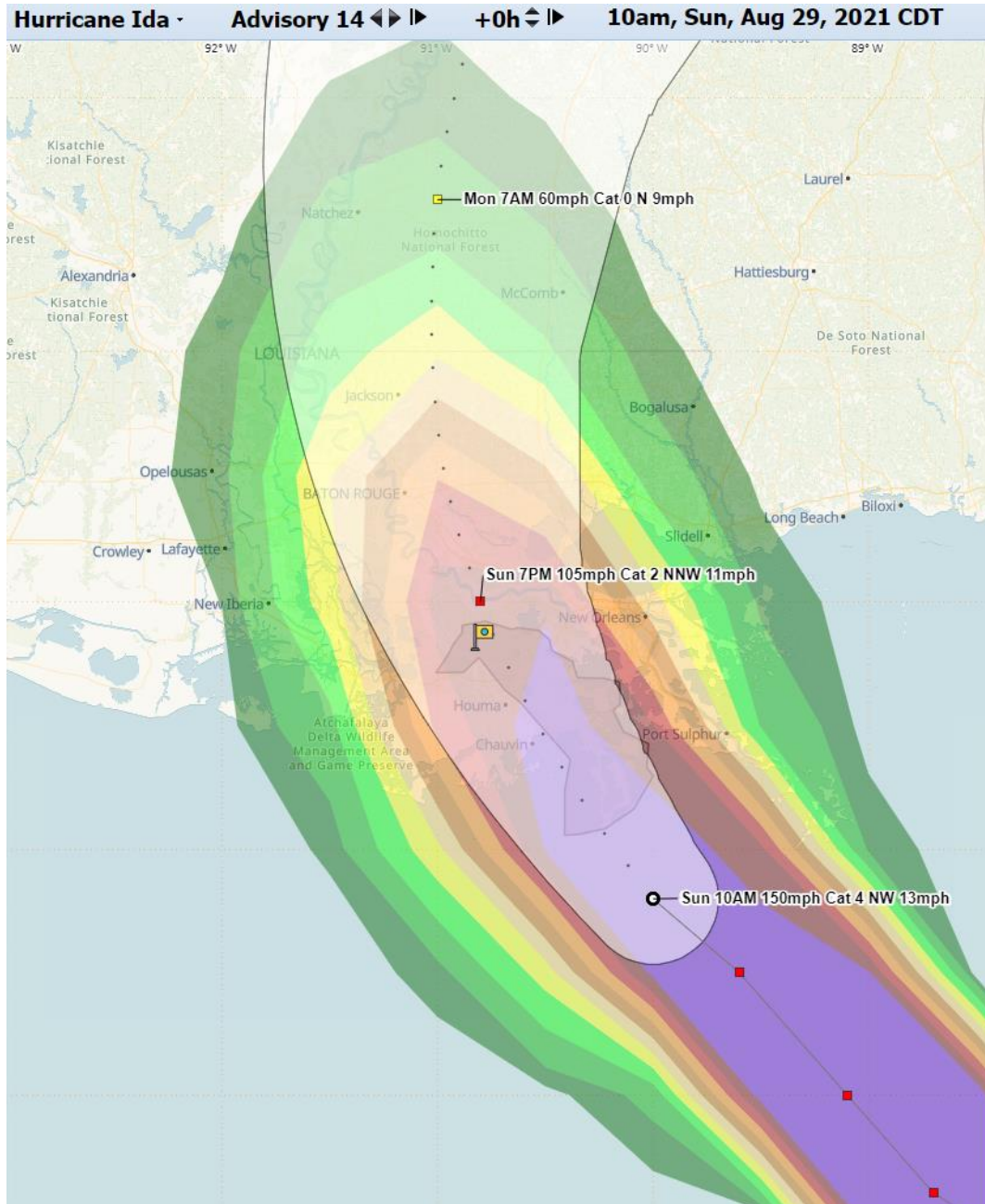

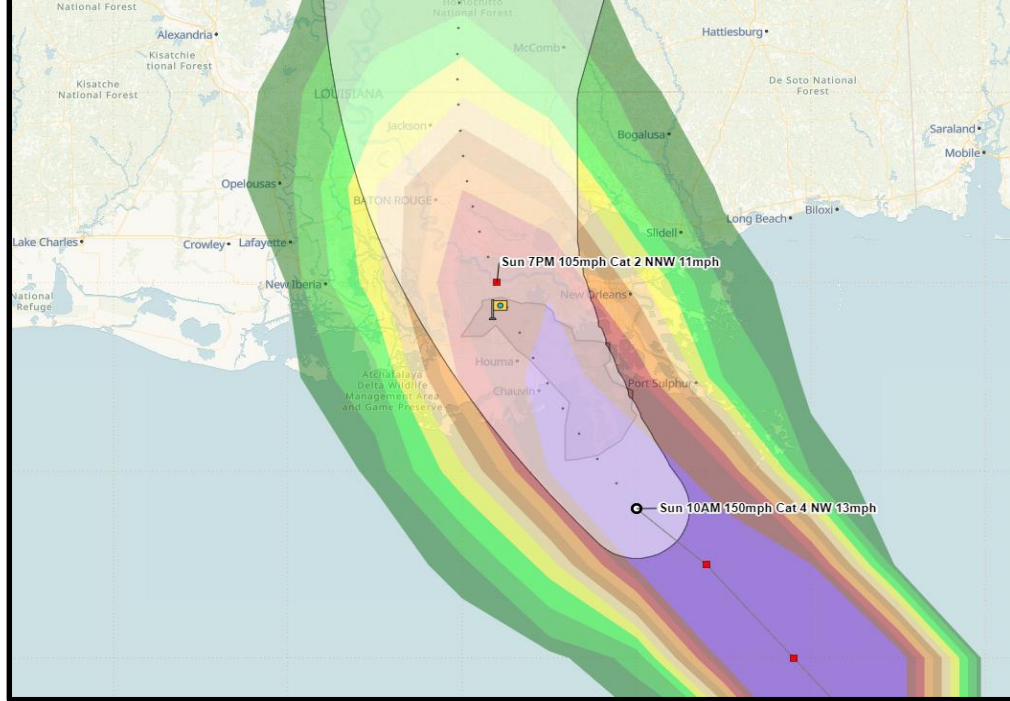

Weather Update



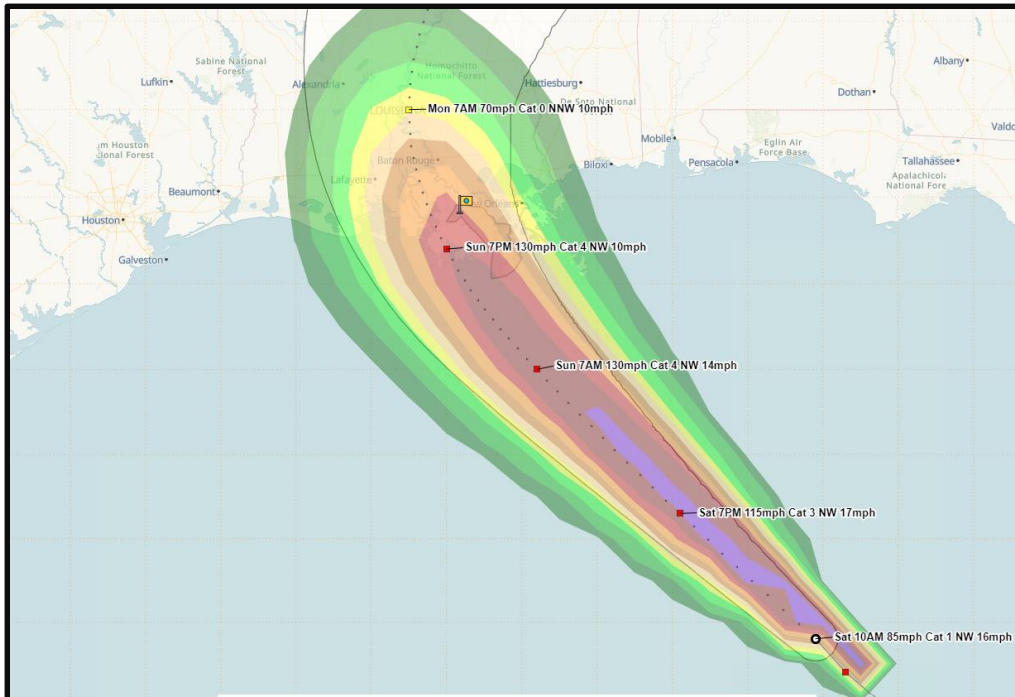
Hurricane Ida
July 28, 2021 11:00am
Mb- **933 mb**
Storm Surge- **10 ft.**
Movement- **NW 15 mph**
Size- **50 miles deep**
Rainfall- **10" over 24hrs**
Wind speed **150 mph**

The storm is now in the most critical phase. Outer and mid bands are making landfall. These impact the core and the eyewall. The next two advisories are the most important indication of when the storm will weaken.

Mayor's Critical Information Requirements

1. Any Tropical Depression or Storm that enters or develops in the Caribbean Sea, the Southern Atlantic Ocean, or the Gulf of Mexico **August 26, 2021**
2. Significant changes in Storm intensity & projected H-Hour (*Tropical Storm winds on Louisiana coast*) Tropical storm winds along the Louisiana coast projected on **August 29, 2021**
3. Regional Parish, State & Federal Declarations of Emergency in Louisiana or any adjacent Gulf Coast State
 - Governor declared a state of emergency on **August 26, 2021**
 - Lafourche Parish declared a state of emergency on **August 27, 2021**
 - Federal Presidential Pre-Land Fall Declaration requested on **August 27, 2021**
4. Any loss or significant degradation of any communication system used by Emergency Management Officials **None**
5. Any evacuation orders by Local Officials **All Region 3 Parishes**
6. Any major issues raised by Parish Presidents or Mayors in potential effected areas **Storm Effects in All Bayou/River Parishes (Region 3)**
7. Any changes to the manning level of the State EOC State EOC **24/7 on August 27, 2021**

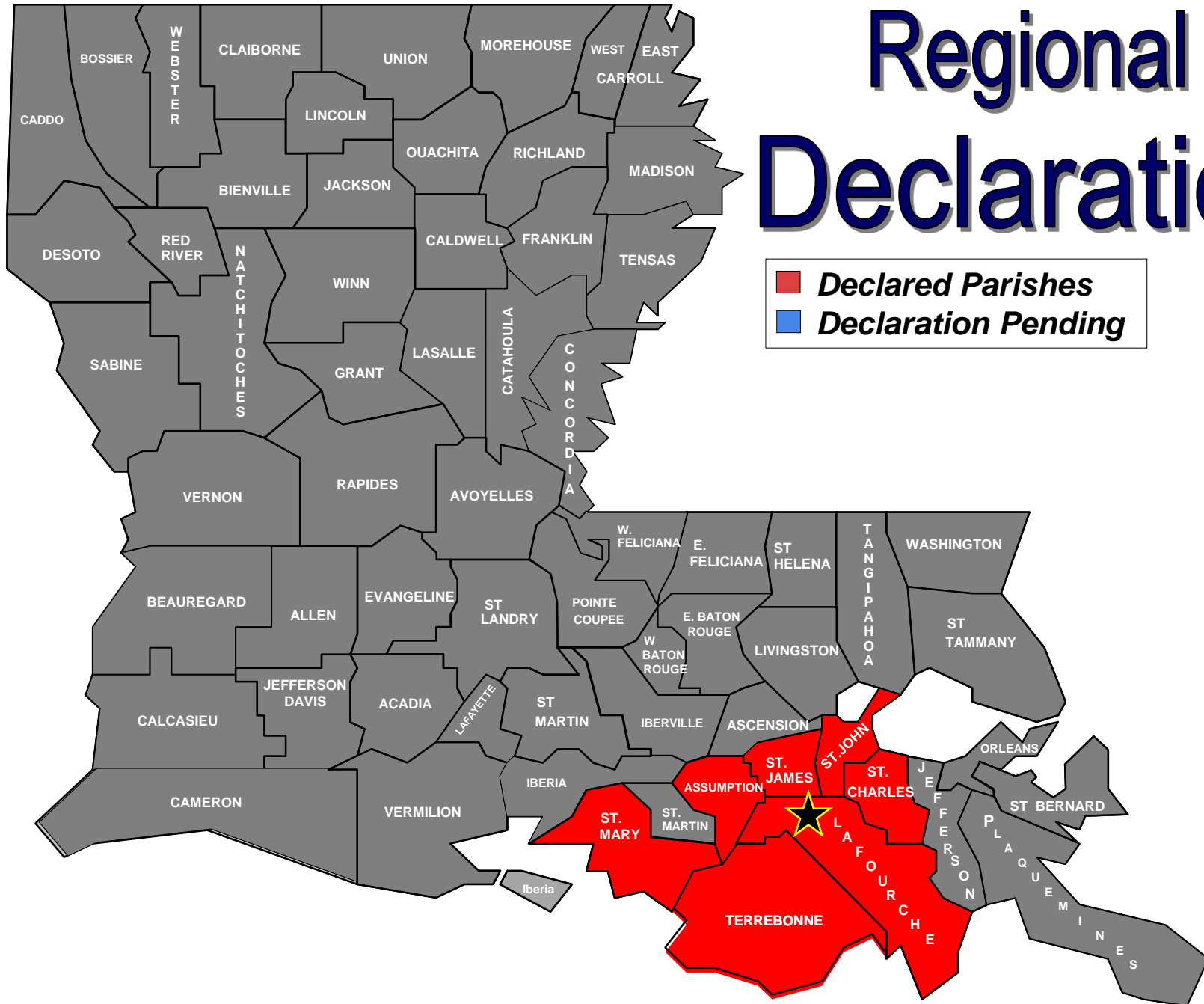
Situational Summary- Sunday August 29, 2021

- 1. The City of Thibodaux (COT) has monitored this event for the past 96 hours (H-96 to H-2) and the Mayor activated the unified command group at H-72 (August 26, 2021 2:00pm)**
- 2. The COT continues to be involved in parish, state and federal conference calls for this storm**
- 3. The COT conducted a UCG on August 29, 2021, issued PSA 3 at H-2 (August 29, 2021 11:00am), published the UCG situational briefing to the emergency alert group, and will conduct another UCG session on August 30, 2021 at 9:00am.**
- 4. The curfew remains in effect until further notice. This is in support of a Parish wide curfew of the same time/duration.**
- 5. City Workers and First Responders are sheltering in place. First Responders will not respond to individual calls as it will not be safe to be outside. Major emergencies will be handled on a case by case basis.**

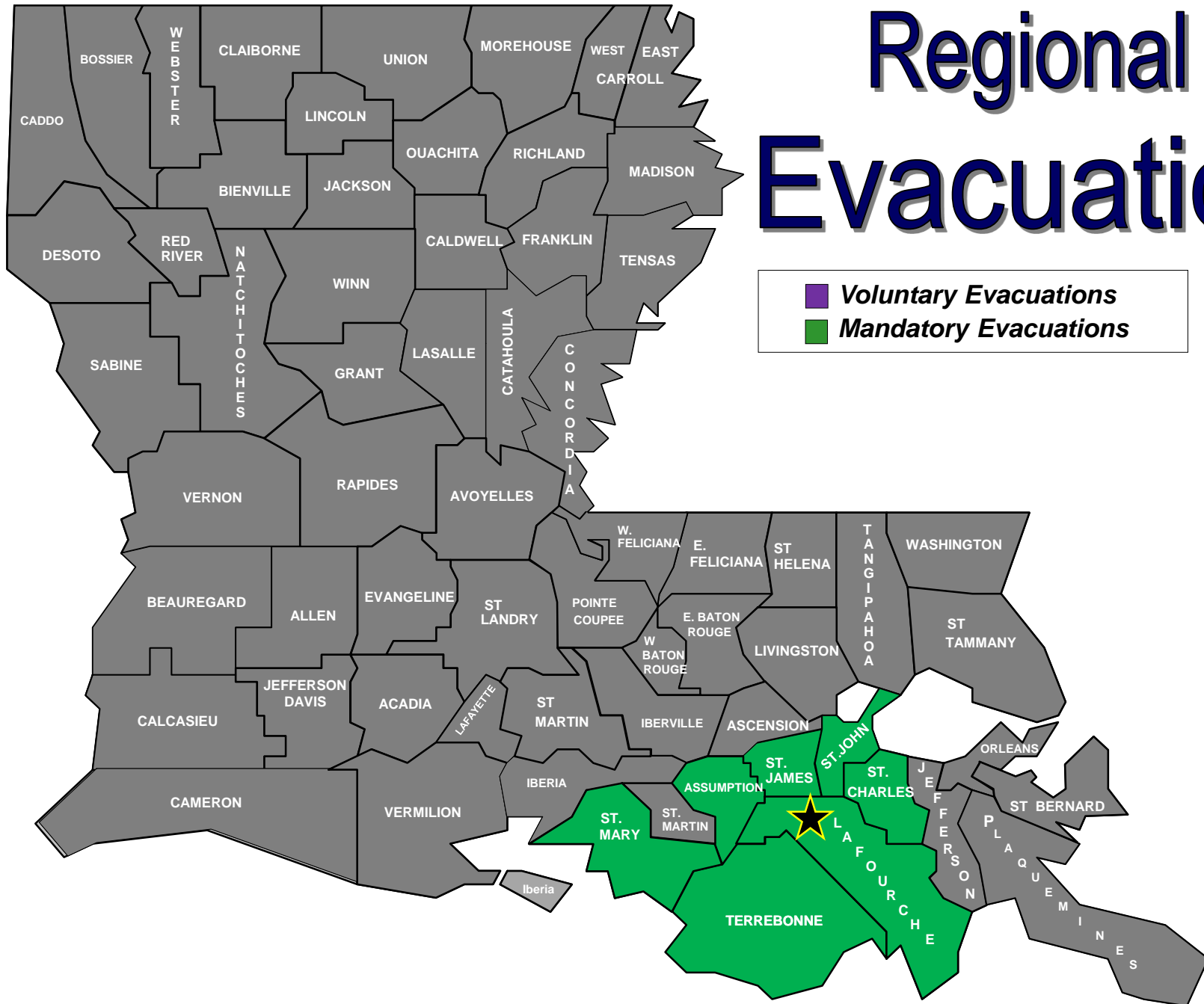
Lafourche Parish Situation

- 1. Lafourche Parish Declaration on August 27, 2021**
- 2. Shelter operations continue at Central Lafourche and Thibodaux High Schools**
- 3. Curfew remains in place until further notice**
- 4. Preparing for post landfall operations**

COT Incident Action Plan- August 29, 2021 Next 24 Hours

- 1.** The COT will continue to monitor the event and make a decisions through the COT's Unified Command Group (UCG).
- 2.** The COT will issue a PSA after the series of conference calls today, August 29, 2021.
- 3.** The message for all is to shelter in place. The time to evacuate has passed.
- 4.** The priority of work for the next 24 hours is the rescue phase of the storm.
- 5.** The COT will not transition to recovery until storm winds drop below 30 mph, Monday morning.
