The minutes of the April 18, 2023 City Council Meeting were approved as written.

Process and Controls Engineering, the engineer for the North Canal Blvd/Martin Luther King Water Tower Painting Project, has submitted Change Orders No. 1 & 2 for the additional services for this project.

Change Order No. 1 is for additional design services for the installation of new pipe, brackets, supports, and valves for the MLK water tank overflow line, and increases the contract amount by \$5,477.50. Change Order No. 2 is for additional services for revising the Advertisement for Bids and generating new bid documents due to the need to re-bid the project. This change order increases the contract amount by \$2,250.00, thereby making the total design services for this project \$16,277.50.

The City's Housing and Community Development Director has received notice of its 2023 CDBG Entitlement allocation from HUD, and now must submit the application for Federal Assistance and the annual action plan for fiscal year 2023. The City's estimated entitlement for FY 2023 is \$148,773.00.

The Finance Director has received a proposal for the City's Fire and Property Insurance coverage for the period June 1, 2023 through June 1, 2024.

The proposal presented by Jones Insurance Services includes a \$10,000,000.00 coverage limit for our updated statement of values of \$44,393,825.00 with an annual premium of \$380,572.00. This premium is a 44.7% increase over last year's premium. The deductible has increased from \$5,000 to \$10,000 with a named storm deductible of 10% with the minimum deductible increasing from \$50,000 to \$250,000. There is also a 1% wind and hail deductible with the minimum deductible increasing from \$25,000 to \$100,000. The Administration is recommending that we renew our coverage with Jones Insurance Services

The Finance Director has received a proposal for the City's Boiler and Machinery Insurance coverage for the period June 1, 2023 through June 1, 2024.

The proposal presented by USI Insurance Services includes \$50,000,000.00 of coverage through Hartford Steam Boiler Inspection & Insurance Company. The annual premium for the proposed coverage is \$15,772.00. This renewal premium is a 5.85% increase from the current premium. The State DOTD has proposed that the City continue to maintain the greenspace along State Highways located in our City under the provisions of an agreement which the City would be compensated for the services. The City will be required to clean and mow the greenspaces a minimum of four (4) times per year.

The agreement proposed is for the period of July 1, 2023 to June 30, 2024 at certain rates of reimbursement depending on the type of highway. In accordance with the provisions of the proposed maintenance agreement, the City would receive \$10,800.00 annually for our maintenance services provided.
