The City Council of the City of Thibodaux assembled in regular session at its regular meeting place, City Hall, 310 West 2nd Street, Thibodaux, Louisiana, on Tuesday, March 5, 2024 at 5:00 P.M.

The minutes of the February 20, 2024 City Council Meeting were approved as written.

The City's Home Rule Charter requires the City Council to provide an annual audit of the City's financial statements. The City received proposals on December 3, 2019 and only received one proposal from Postlethwaite & Netterville, which is now EisnerAmper. The proposal is for a term of three years with the option to renew for two additional one year periods, and EisnerAmper has submitted an Engagement Letter authorizing them to perform our auditing services for FY 2023. The engagement letter proposes to perform our 2023 financial and compliance audit at a cost not to exceed \$83,500.00. It also stipulates that if it is determined that any additional major federal programs require to be audited, it would result in charges of \$12,000 per program.
