The City entered into an agreement with Royal Engineering and Consultants dated February 19, 2025 for consultant services for the mill and overlay of Audubon Ave. from LA 1 to the Terrebonne Parish line. The consultant was selected by LA DOTD as this is a state project, but all documents are executed by the City.

The Grants Director has informed the Council Administrator that the City has received Supplement No. 1 to the engineering contract with Royal Engineering and Consultants in order to increase the compensation to the consultant based on the actual work performed and the allowed direct expenses incurred in the amount of \$20,600.00. The total contract price will increase from \$117,782.00 to \$138,382.00.
