Bids for the above referenced project were received on Tuesday, December 16, 2025 at the City of Thibodaux's Council chambers. We received five bids on the project which are detailed in the attached bid tabulation.

At this time, DDG recommends that the base bid and Alternate 1 be awarded to Next Generation Sports Surfaces, LLC provided adequate funding is available.

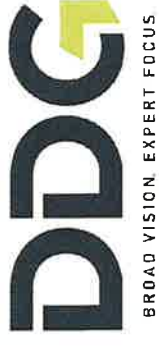


