THIS SUPPLEMENTAL AGREEMENT is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the City of Thibodaux, a political subdivision of the State of Louisiana (hereinafter referred to as "Entity"), and Royal Engineers, and Consultants, L.L.C., New Orleans, Louisiana (hereinafter referred to as "Consultant").

The Entity and the Consultant entered into a Contract on February 19, 2025, to mill and overlay Audubon Ave. from LA 1 to the Terrebonne Parish line, in Lafourche Parish, more specifically described in the said Contract.

It is hereby agreed between the parties hereto that the Contract of February 19, 2025, be further modified as follows:

**SCOPE OF SERVICES**

The services to be performed by the Consultant shall remain as stipulated in the original Contract.

**COMPENSATION (September 2025)**

*This article has been revised in accordance with Louisiana Act 204 (2024 Regular Session) requiring all consultant contracts to be negotiated.*

Compensation under this agreement shall be based on work hours negotiated and agreed upon between the Entity and the Consultant prior to the performance of services.

Compensation to the Consultant for the services to be performed under this Supplemental Agreement shall be based on specific rates of compensation for the actual work performed and the allowed direct expenses incurred by Consultant, with a maximum limitation of **\$20,600**.

The maximum compensation payable to the Consultant under this Contract is hereby increased from **\$117,782** to **\$138,382**, which includes compensation under the Original Contract and Supplemental Agreement No. 1.




