### TREC SUMMER YOUTH CAMP

### (TREC Behavior Management Procedures)

It is TREC's goal to provide a healthy, safe, and secure environment for all day camp participants and staff. The TREC Summer Youth Camp will teach the core values of caring, honesty, respect and responsibility. Children who attend the program are expected to follow the behavior guidelines and to interact appropriately in a group setting.

#### BEHAVIOR GUIDELINES

- People are *responsible* for their actions.
- We *respect* each other and the environment.
- Honesty will be the basis for all relationships and interactions.
- We will *care* for those around us and ourselves.

When a camper does not follow the behavior guidelines, we will take the following steps:

- 1. Staff will redirect the camper to more appropriate behavior.
- 2. The camper will be reminded of the behavior guidelines and day camp rules. Counselor will issue a time out (1 minute per year old). Camper should be able to explain to you what was inappropriate and how to correct it. (Document on incident report to be turned in at the end of each shift.)
- 3. Counselor/camper conference. (Warn camper and document on same incident report to be turned in to the Director at the end of each shift.)
- 4. Director or Head Counselor/camper conference. (Document on counselor's report.)
- 5. Call to parent or behavior letter to parent. (Document in discipline folder.)
- 6. If a child's behavior at any time threatens the safety of that child, other children, or staff, the parent will be notified and expected to pick up the child immediately.
- 7. If a problem persists and a child continues to disrupt the day camp program, TREC reserves the right to suspend the child from the program. Expulsion from the program will be considered in extreme situations or after the second suspension.

The following behaviors are not acceptable and may result in the immediate suspension of a camper for the remainder of the current day, the next day or the remainder of the session:

- Endangering the health and safety of children and / or staff, members and volunteers.
- Stealing or damaging TREC or personal property.
- Leaving the TREC Summer Youth Camp or group without permission.
- Using profanity, vulgarity, or obscenity frequently.
- Acting in a lewd manner.
- Continual disruption of the program.
- Refusal to follow the behavior guidelines set forth by the camp and counselors.

If any of these behaviors persist, staff may suspend the camper a second time before expulsion. No refunds given due to discipline problems!

Immediate expulsion will occur if a camper is in possession of and / or uses tobacco, alcohol, illegal drugs, firecrackers, firearms or explosives. No refunds given due to discipline problems!

PLEASE NOTE: TREC counselors, coordinators or administrative staff shall not administer any type of medication to children enrolled in the summer youth camp. However, "rescue medications" (such as Epipens, insulin, Benadryl, inhalers) will be administered by trained camp staff only if parent/guardian signs authorization form giving staff permission to administer medication. The correct dosage shall accompany the authorization. The medication must be labeled with the child's name and in its original container. It is the parent's/guardian's responsibility to bring the medication into the camp office.
