

Title: Police Support Technician

FLSA Status: Non-Exempt

BRIEF DESCRIPTION:

The purpose of this position is to provide technical support for the police department. This is accomplished by handling animal control complaints; maintaining all signs within the city limits; and assisting officers with other tasks as needed. Other duties include assisting with special events.
